**MOTION – (1:33:35) Recording 1**

*A motion was made by Board President Miller to approve the recommendation by the Department of Education for membership on both the English Language Arts subcommittee and the Mathematics subcommittee. The motion was seconded by Member Mari Koerner.*

**AMENDMENT – (1:34:26) Recording 1**

*Member Taylor moved for an amendment to the motion to replace a Math subcommittee member with Mr. Mike Robinette and to replace an ELA subcommittee member with Claire Morgan. The amendment was seconded by Member Chuck Schmidt.*

**AMENDMENT to the AMENDMENT – (1:45)Recording 1**

*Superintendent Douglas moved to amend Mr. Taylor’s amendment. The amendment would remove the Early Childhood position on the ELA subcommittee and the Early Childhood position on the Math subcommittee and add an advanced Math slot to the Math subcommittee. The motion was seconded by Member Tarro.*

- Clarification from Council (Kim Anderson) to the subject of “amending an amendment.” Council clarifies, that an amendment to an amendment can only be done if the first amendment has been voted on and passed.
  - Superintendent Douglas withdrew her request to amend Mr. Taylor’s amendment.

**VOTE ON ORIGINAL AMENDMENT BY MEMBER TAYLOR (2:21) Recording 1**

*Mr. Taylor restated his amendment: The amendment replaces a Math subcommittee member in the Algebra 2 slot with Mike Robbinette and replaces an ELA subcommittee member with Claire Morgan in the 10<sup>th</sup> grade ELA slot. The amendment was seconded by Member Chuck Schmidt.*

*The vote was: 8 yes, 7 no & 1 abstention, the motion passes.*

**AMENDMENT (9:31 - Recording 2)**

*Dr. Robbershott moved to amend the original motion as amended to include the addition of an Advanced High School Mathematics slot that should be filled by Mr. Robbinette, pending his acceptance.*

*Vote is 9 yes & 7 no. The amendment passes.*

*A vote on the original motion, as amended, to approve the recommendation by the Department of Education for membership on both the English Language Arts subcommittee and the Mathematics subcommittee.*
